#### Motion: To amend FLUE Policy 1.10-g as follows:

**FLUE POLICY 1.10-g:** In order to promote open space and protect rural and agrarian character, the Town will base density and intensity calculations on net acreage as defined in section "II.A Definitions" of this Plan. Additionally, the counting of water bodies that are not wholly contained within a single lot toward minimum required net lot area for a dwelling is strongly discouraged. In no event shall a water body be counted toward minimum required lot area for a dwelling if the water body traverses more than <u>one lot two lots</u> in a single development / subdivision.

#### Motion: To amend FLUE Policy 1.15-j as follows:

FLUE POLICY 1.15-j: The Town shall not accept a building permit application, nor issue a building permit, unless the applicant presents evidence from Broward County either that the impact of the proposed development on the regional transportation network <u>concurrency has been satisfied</u> has been mitigated by payment of road impact fees or transit impact fees, based on the appropriate provisions of the Broward County Land Development Code, or that no such payment is due. The County Commission may adopt land development regulations which exempt from this requirement categories of building permits that clearly do not create additional transportation impacts.
