Call to order at 7:10 PM. A Quorum was established for both the Advisory Boards.

Nancy Hartmann motioned to excuse the absence of the members listed above. Rose Allbritton seconded and the motion passed unanimously.

Note: The minutes of the January 2017 RFNRAB meeting were inadvertently excluded from the meeting package during copying in preparation for this meeting. Board members agreed to review and officially vote to adopt at next meeting.

Members of the Rural Public Art and Design Advisory Board were invited to be present to give input on color selections now due for the phase one improvements now in progress at Calusa Corners park. Staff briefed the members present regarding the components to be installed and potential color choices. Discussion followed with members from both boards offering input.

Staff briefed the members present regarding the Fiscal Year 2018 Budgeting process, which is beginning. Board member input is requested for development priorities for capital improvements. Staff presented the Board with the Fiscal Year 2017 Capital Improvement Project pages, challenges inherent in the development of parks with little funding, and the directive to continue following the priorities set forth in the Town's Comprehensive plan and commitments of the grant agreements. A period of discussion followed and staff will request the Board to vote on priorities at the March meeting.

Mayor Doug McKay briefed the members present regarding commercial prospects for development on the Southwest Meadows Sanctuary property within the 5-acre portion of the parcel for which purchase was not supported by grant funding, and potential park development and tax benefits that could result from consideration of the prospect.

Staff briefed the members present regarding parks maintenance issues, development updates at Calusa and Trailside Parks, and upcoming events including: Garage Sale, Chili Cookoff and Water Matters Day.

Staff briefed the members present regarding work on the proposed resolution in support of wildlife, to be presented for Board review and potential recommendation to Council at a future meeting.

Staff briefed the members present regarding a request for waiver of attendant requirement at Rolling Oaks Barn for upcoming reservation for Ann Saunders, also mentioning a Board member who is in the process of confirming a reservation. Board members discussed and agreed that the requirement may reasonably be waived in the case of parties with a demonstrated commitment to the Town and to Parks Policies (i.e., Board members, proven renters).

There being no further business to discuss, the meeting adjourned at 9:15 pm.
