EQUESTRIAN PARK

Equestrian Oasis Refurbishment: The fountain has been replanted. A proposal is working in process for refurbishment of some of the cement work of the sculptures. New ground covers have been planted at the top of the berm and pine straw mulch has been placed to reduce erosion on the sandy berm.

Fence Repairs: The fence sections damaged in Hurricane Irma have been repaired.

Signs: Stained signs were cleaned and relocated to avoid further staining by irrigation.

Mounting Block Refurbishment: Proposal for this and other railroad ties to be replaced is anticipated. **Pathway fill:** Proposal for filling the boy scout pathway with pea rock is expected.

Nature Trail signs: Have been re set. A Purple Martin House donated by Chris Brownlow was installed.

ROLLING OAKS

LED pathway lighting: New batteries will be placed in lights. These lights do not receive enough sunlight to remain fully charged.

East Room Kitchen Sink: The drain was serviced. Visitors are requested to be cautious for flooding.
Freezers: Freezers were installed so that events have access to ice available from Councilmember Jablonski.
Butterfly Garden / Fitness Trail signs: A proposal is being sought to refresh the World Trail signage.

COUNTRY ESTATES PARK

Basketball Goal: The goal was apparently damaged by someone seeking to pull it out. It is now slightly crooked, due to being bent at the base of the pole. Staff has requested users to report if the goal is still usable or if it must be replaced.

TRAILSIDE "FOUNDER'S" PARK

Completion of Pavilion and Entrance sign: Work is near complete.

SOUTHWEST MEADOWS SANCTUARY

Staff is researching the contractor's obligation to maintain the work area for the duration.

CALUSA CORNERS

Dykes Road Drainage Project: Council awarded the contract on this project to improve drainage/alleviate flooding on Dykes Road via a connection from Calusa Corners and Southwest Meadows Sanctuary properties to the water body east of both, with a small canal and filter marsh. The Town's Community Wildlife habitat team is working on interpretive nature trail signage. This will satisfy an additional grant commitment at this park.

TOWNWIDE TREE MAINTENANCE

Clearance Pruning: has been completed on multiple rights of way. Further work is approved and will be scheduled to address Town parks and other properties to maintain sound tree structure.

"Snag campaign": At locations in Town where a tree or palm has died and has been observed to be in use by wildlife, staff has posted signs to create awareness around the Town's response to wildlife needs.
