Subject: Park security

Good afternoon December,

As a follow up to our conversation and the request of the Parks Board, I have reached out to the Town Attorney and Davie Police to review our options in dealing with the ATV's and 4-wheelers that run through the Town's parks.

Our options are very limited.

While Davie Police will attempt to make contact and disburse offenders, for safety reasons they will not pursue. In most cases, the offenders flee, and chasing them may place the officer and the off road vehicle operator at risk.

It is my understanding all Town parks have a 'no motor vehicles' sign at the park's entrance. This is good, but we need to add additional signage that indicates the officers have the right to have a vehicle towed if it is operated improperly in a park. As we discussed, you will obtain signage from Superior Towing, and will supplement those signs as needed. This way, should Davie Police have the opportunity, they will be able to have the offending vehicle towed. Cost of towing and recovery will the responsibility of the vehicle owner (or their parents). This will hopefully cut down the number of offenders.

Another option will a targeted operation or 'sting'. We can assign multiple officers to a site in advance. **This will only be effective if we know where and when in advance**. This would allow us to seal off the escape options. If we are able to do this, we would use it as an outreach opportunity to educate the public, and let them know there would be zero tolerance going forward.

EQUESTRIAN PARK

Entrances Signs Refurbishment: The north entrance sign is in the process of being refurbished. Background will be cleaned and painted, letters will be cleaned and reattached.

Restroom and Picnic Pavilion: Staff is working on procurement for painting interior and exterior.

ROLLING OAKS

Maintenance: Replacement of wind-blown shingles will soon be in progress. Rusted parts of locks and doors have been repainted. The concrete breezeways were cleaned and resealed. Staff is working on procurement for painting interior and exterior.

COUNTRY ESTATES PARK

Picnic Pavilion: Staff is working on procurement for painting interior and exterior.

SOUTHWEST MEADOWS SANCTUARY

Fill contractor is performing as expected without issue. Additional funds have been received by the Parks Foundation, as per the agreement.

CALUSA CORNERS

Picnic Shelter: Staff is working on procurement for sealing the tongue and groove ceiling.

FRONTIER TRAILS PARK

Picnic Shelter: Staff is working on procurement for sealing the tongue and groove ceiling.

TOWN WIDE MAINTENANCE

Parks, Right of Way, Irrigation and Facilities Maintenance: Recommendation will come before Council in March for these services. Many companies participated in the RFP process and there was much competition.

FOUNDATION

Southwest Ranches Parks Foundation Donor Tree: Price structure has been set by the Board of Directors. A newsletter item is being prepared to run on an ongoing basis.
