
Ad valorem (Property Tax) Introduction

Latin: "according to value" Whose Value?

Market Value - What Someone will Pay

Assessed Value - What the Tax Appraiser believes is a fair value for the property

Taxable value - What the millage rate can be multiplied by (Assessed - Exemptions)

COMBINED RATE IMPACTS


- Maintaining 3.9404 mills means slight property tax increases (\$35 per \$250,000 in taxable value) to no increase (depending upon exemptions) for some residents.
- Coupled with proposed fire and solid waste assessment rates, many residents will see an increase from the Town of Southwest Ranches of \$34.03 annually or less than \$2.84 monthly.

(Ad Valorem + \$35; Fire + \$29.63; Solid Waste - \$30.60 = \$34.03 annually)


Fire Assessment

- Permitted by Florida Statue Chapters 166.021 and 166.041.
 - "A fair and equitable contribution towards expenses associated with the development, maintenance and future capital expenditures shall be distributed among all properties benefitting from the existence of these services".
- Annual rate establishment required by Town ordinance 2001-09.
- Initial resolution needed tonight to meet Truth-In-Millage (TRIM) advertising requirements.

Fire Assessment Residential and Acreage Category Rates Three Year History and Proposed FY 2014



Fire Assessment Rate: Per square foot by Category Three Year History and Proposed FY 2014



Fire Assessment Impact

Single Family residential: \$29.63 increase (per dwelling)

Commercial: \$.06 increase (per square foot)

Industrial / Warehouse: \$.22 increase (per square foot)

Institutional: \$.03 increase (per square foot)

Vacant/Agricultural: \$23.80 (per acre)



Solid Waste (Garbage) Assessment

Permitted by Florida Statue Chapters 197.3632.

- Annual rate establishment required by Town ordinance 2002-08.
- Initial resolution needed for the assessment to comply with Florida Statutes and use of Truth In Millage (TRIM) notices

Solid Waste Impact

- Approximately 5.5% decrease overall this year in addition to the approximately <u>30% cost</u> <u>savings</u> for residential collections across <u>all</u> residential categories last year (FY 2012-2013).
- Residential Solid Waste customer reductions range from \$11.72 - \$30.60 annually depending on lot square footage.

Conclusion:



It is your Town Administrator and Town Financial Administrator recommendation that the Town Council of Southwest Ranches adopt the resolutions presented tonight <u>setting the rate maximums</u> which primarily provide for an aggregate (combined) increase in FY 2013-2014 monthly cost of less than \$2.84 or \$34.03 annually to residential homeowners of \$250,000 in taxable value with a lot square footage of less than or equal to #41,200 related to the:

Millage (Property Taxes) Rate,

Fire Assessment Rates,

and Solid Waste (Garbage) Assessment Rates
