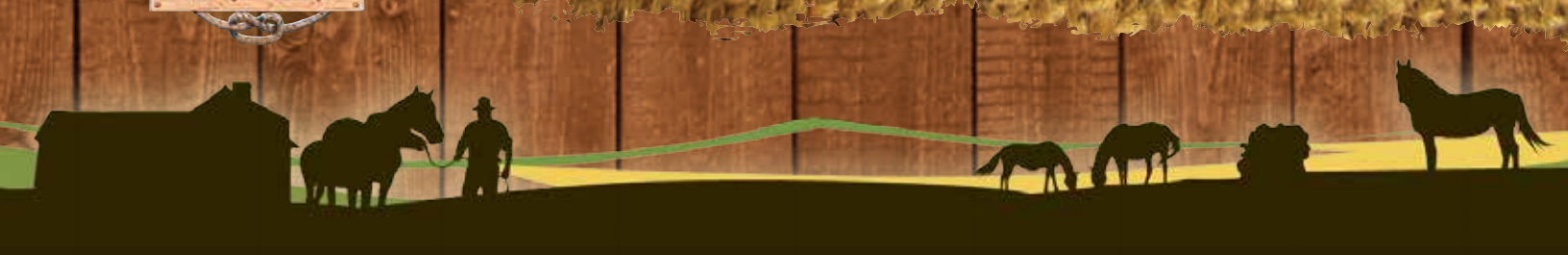

One of the things I am most proud of in our town is the way we can do things in a non-

governmental way. That may entail volunteer work that keeps our costs and taxes down or it may be other ways that we try to do more with less involving various organizations in town or through great new ideas from residents or town staff.

An excellent example of that is the opportunity to bring building permit reviews in house. We have historically had an excellent partner in reviewing our permits. It was a team that we have worked with for many years and they have done a great job. However, our Town Administrator, Andy Berns, working with his staff worked out a plan to bring this portion of zoning and planning in house. Many times it's only when something is broken that we stop and look at it to see how we can fix it and make it better. In this case it was working fine but it was reviewed anyway to see if there was a more efficient way to accomplish the task. And they found that there was!

In the first 6 months of the switch the cost to our residents for moving this in house was \$30,152. If the change had not been made, the cost to our residents would have been \$53,779. That is a savings to our residents who came in for permits of a total of \$23,627. That's an almost 44% decrease in cost. The other benefit is that this service is now available in our town hall rather than having to leave our town to have the service provided. So it is a big plus from a time standpoint as well.

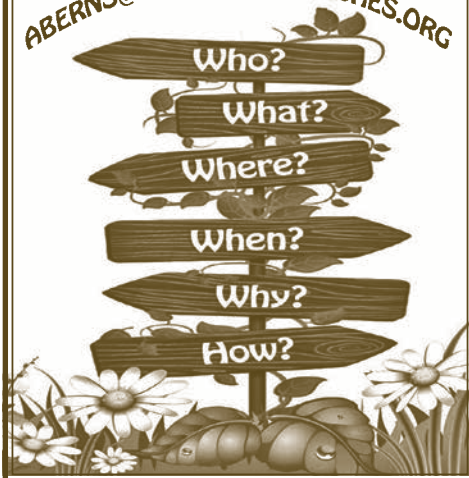

This has been a month with not a lot of new things to report to you about what is going on in the Town and the area around the Town that have affected us. In my opinion what is happening on Griffin Road west of the bridge west of SW 184th Avenue this section was not made four lanes like the rest of Griffin. A little history of this road was when Weston was built there was an agreement between Broward County and Weston that they would not have to make Orange Drive a major road as it is east of I-75, and they could use Griffin Road to do this but they would have to make Griffin Road a four lane road. When we had meetings on forming our Town that subject was brought and they said was not the present plan. We objected to this and said it had to be done or they would have to remove the bridge so they went back to Weston and a plan was agreed to that Weston would be responsible for building part of the road and Broward County would be responsible to build the other part which was done. But nothing was done with the part west of 184th Avenue. That is why the section west of 186 Avenue is not four lane. One of the persons working on this is a lady Mary Macfie, according to a card I was given she is listed as the 1st Vice President of the Broward Coalition Inc. And she lives in our Town. She is trying to have that section of Griffin

Road made four lane for safety reasons. At our last meeting of the MPO (Broward Metropolitan Planning Organization) she spoke on this subject and the question was asked did her Town have a resolution supporting this and because I am a member of this organization representing the Town of Southwest Ranches. I said I would find out and when I checked with our Town Administrator Andy Berns he informed me we don't. So this is where we are with this subject.

DAVIE POLICE DEPARTMENT FIREWORKS SAFETY

We at the Davie Police Department want to make sure that everyone has a safe and happy Fourth of July. We also want to remind everyone of the dangers of illegal fireworks and provide a few safety tips to help keep you safe this Independence Day.

- Florida law prohibits any fireworks that fly through the air or explode. Things like roman candles, bottle rockets, mortars, etc.

are all illegal.

- Firework accidents injured nearly 10,000 in the United States last year alone.

So, even if you purchase legal fireworks (sparklers, etc.), please use them in a safe manner by following these safety tips from the National Fire Protection Association:

- Keep a fire extinguisher or water hose on-hand for emergencies. It's a good idea to drop used sparklers in a bucket of water.
- Use sparklers and other legal novelties on a flat, hard surface in an open area. Do not light them on grass.

- Keep children and pets at least 30 feet away from all ignited sparklers.
- Light only one item at a time and never attempt to re-light a "dud."
- Don't use any unwrapped items or items that may have been tampered with.
- Only purchase fireworks from licensed vendors.
- Never allow young children to play with or ignite fireworks. After the firework display, children should never pick up fireworks because they may still be active.
- Never have any portion of your body directly over a fireworks device when lighting the fuse.

Southwest Ranches FIRE RESCUE

There has been much discussion recently about the Volunteer Fire Department, and we'd like to provide an update on changes made by the Town Council and the operational direction given. Fire operations were reviewed thoroughly last year, and prior to the Council discussion in November, changes were discussed thoroughly by the Town's Fire Advisory Board, composed of Town residents who are also career professional fire service experts.

Prior to last November, we had been staffing 3 firefighters per shift. In order to continue to fund the Volunteer Department, but to do so as cost effectively as possible, the Town Council reduced the 24 hour staffing to 2 firefighters. Stipends paid to firefighters and the Chief and Assistant Chief's salaries were also reduced substantially. These changes, combined with other minor

reductions, have reduced the Town's cost for the Volunteer Department to an anticipated \$378,139 for the current fiscal year.

While the Department does fundraising (such as our very popular Santa runs), the majority of our funding is provided by the Town. Town financial support for the Volunteer Department peaked at \$501,789 in 2014, and is projected at \$298,387 for next fiscal year.

At the Council meeting on May 14, the Council approved the purchase of a new fire truck. Our current truck (Engine 82) is 20 years old, and subject to frequent breakdowns. This costs not only the money to repair, but having this engine on the sidelines makes it difficult to provide the high level of service our residents deserve. The new truck will allow us provide proper service, as well as carry the equipment necessary for both fire and EMS (medical) calls. The

amount approved for the new truck was \$206,497, which will be paid over 8 years, at a tax exempt interest rate of 2.56%. Payment for the truck will come out of our annual budget, and will not be an additional expense.

While Davie Fire Rescue has done an outstanding job protecting our community, given the location of their various stations, coverage out west becomes more of a challenge. Recognizing this, the Council directed us to work with Town staff to relocate the Volunteers from the existing shared station at 17220 Griffin Road to a location further west. We are currently working on this, and are trying to move quickly, yet as cost effectively possible.

Our goal is to provide as high a level of service as possible to the residents of Southwest Ranches. If you have any questions regarding the Volunteer Fire Department, please contact Chief Lee Bennett.

VULNERABLE POPULATION REGISTRY

REGISTER NOW... HURRICANE SEASON IS HERE!

The Vulnerable Population Registry is a program that allows people who would be at risk following an emergency to register in advance so that emergency workers may plan a better response during a recovery effort. The Registry is a joint partnership between municipalities and Broward County. Each municipality may use the Vulnerable Population Registry list in a different way, based on their local recovery effort.

WHO SHOULD REGISTER

You should register in the Vulnerable Population Registry if you elect to stay at home during an emergency and have a disability, frailty or health issue that would make you vulnerable in an emergency. If you live in an evacuation zone, you should plan to evacuate. (See the town's web site for the emergency shelter map: www.southwest ranches.org).

HOW DO I REGISTER?

The easiest way to register is online at Broward.org/Atrisk. You can register yourself, or a family member or caregiver can register for you, if you authorize them to do so. If you don't have access to a computer, you can also register by

calling **Town Hall (954) 434-0008**, or the **Broward County Call Center at 311 or 954-831-4000 (TTY 954-831-3940)**.

REMEMBER...

- Register only once. If you move, or no longer want to be included in the Registry, call Town Hall or the Broward County Call Center to update or delete your registration.
- Registration is not a guarantee that you will be provided services or placed on a priority list for emergency responders, but it will help the town to better respond during a recovery effort.
- All information will be held in the strictest confidence as required by State law.

If you have a medical condition that requires a greater level of care than provided at a General Population Shelter, but you do not require hospitalization or a medical institution, a Special Needs Shelter may be appropriate for you. These shelters offer basic medical assistance and monitoring. Pre-registration for the Special Needs Shelter is open throughout the year, and requires your physician's involvement. To request or obtain an application for a Special Needs Shelter, call **Broward County Human Services at 954-357-6385 (TTY 954-357-5608)**. Pre-registration is strongly encouraged to ensure the shelter will be adequately prepared to meet your needs.

CODE ENFORCEMENT AND YOU: "BE A GOOD NEIGHBOR, ISSUES THAT AFFECT US ALL"

Our Town of Southwest Ranches is a rural community and strives constantly to maintain the character that our founders and residents envisioned. Many times without realizing we tend to deviate or stray away from this vision, either because we forget or because we are new to our area. This article serves to communicate with our established and new residents that one needs to be conscious of the impact that can be created to adjacent neighbors by our actions and "be a good neighbor". Such issues as excessive noise created by volume, amount of guests attending a party, allowing our landscapers to blow debris and clippings onto the street, allowing our dogs to run loose along the streets and neighborhoods, and the failure to obey speed limit signs, are some of the things that we will be addressing in this article.

• Noise Limits (volume, time of day), attendees, parking impact

Recently the Department has seen an increase in the amounts of complaints related to excessive noise beyond a reasonable time. Many cases relate to parties that start late and continue to even later evening hours or early morning hours, creating noise beyond the normal levels. As a reminder, we follow the regulations that are part of Town of Southwest Ranches Unified Land Development Code, Section 035-080 when it relates to noise. Our code does not allow for noise amplified or non-amplified to be audible from an adjacent dwelling or guest house (with closed windows and doors) from the hours of 8:00 p.m. to 9:00 a.m. Monday to Friday and 11:00 p.m. to 9:00 a.m. Saturdays and Sundays. Also as related to New Years' Eve the hours where no amplified or non-amplified noise cannot be heard in the same manner are from 1:00 a.m. to 9:00 a.m. on New Years' Day. In addition, a residential special event assembly application is required if the assembly will be attended by more than 30 people. This permit needs to be submitted within 15 business days from the date of the event.

In addition these parties have presented traffic and parking issues to adjacent neighbors due to the amount of attendees and the parking of vehicles obstructing traffic and side streets. We need to be conscious that a large amount of vehicles parked along our narrow streets and in front of properties, create an impact on our neighbors. The Police Department has been called to these events because cars are blocking traffic lanes, and driveway entrances. Please be mindful of your neighbors and the impact that this issue creates.

• Landscape Work and Debris

It has become a common practice for landscape companies and workers to blow their clippings and debris onto our streets in front of the property that they are servicing. As a result and given the fact that we have drainage issues in many areas, the clippings and debris clog the few culverts that are used to dislodge and move the water accumulated on our roads to avoid road flooding. It is imperative that as a resident, you take it upon yourself to notify your landscapers to avoid this practice. In general this is something that the landscaper should do, and that is to collect and dispose of the clippings that are part of their landscape operation. As a requirement, any company that operates in the Town providing landscape services, is required to remove all debris from residences and not place them on the right of way. This practice provides for a more appealing neighborhood while the previous one, serves to reduce the value of our houses which we work hard to maintain and are proud of. Please help us control this issue.

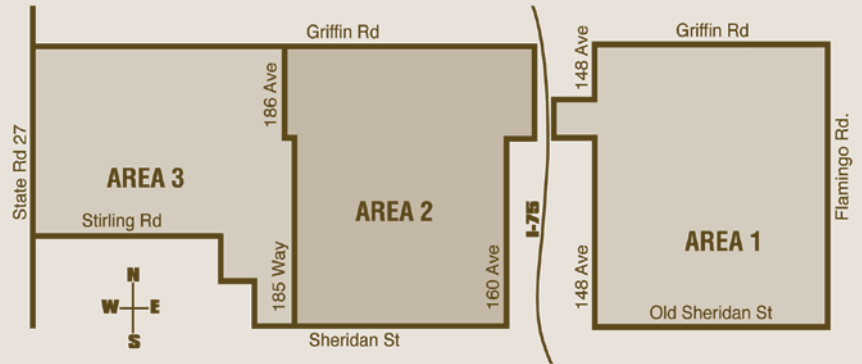

• **Dogs roaming freely / no leash or out of the yards**

When the Code Enforcement Department receives a complaint from either a resident or our Police Department related to loose dogs, a case is created as it is considered to be a nuisance. The law does not allow for dogs to run loose on our streets. It becomes a dangerous proposition for a resident that is walking along the streets, exercising or for children that may be playing. Dogs need to be confined to their yards (following proper maintenance procedures, such as providing water, food and shelter from the elements), or walked on a leash to prevent any and all possible accidents. Many of our residents have been bit by loose dogs, and in other cases we have had instances where dogs are not properly maintained with food or water which is also not legal and will be enforced by the Code Enforcement Department.

• **Obeying speed limits signs**

The Police Department continues to enforce speeding along our internal streets. Unfortunately, many residents are some of the biggest offenders. We need to obey speed signs, they are there to provide information to drivers that by law they need to follow. The maximum speed on the speed signs are calculated based on the location, width of the street and other factors. The failure to obey speed limit signs, creates two possible outcomes. On one hand, a resident that is walking along our streets or riding a bicycle could be hit by a car, and in addition, you may be ticketed for speeding. Please, for the sake of our children and fellow residents obey speed signs.

As a reminder, the Code Enforcement Department only works based on complaints from residents as it is non pro-active in nature. We believe that

everyone has the right to enjoy their property without any outside intrusion. Notwithstanding this fact when a complaint comes into the Department we have to investigate and provide the corresponding notification to the property owner.

We all live in a beautiful and special Town. The Town of Southwest Ranches would like to ask for our new and established residents to be mindful of these issues and help us continue to maintain the character that we all envisioned. Let's work together to make sure that these simple guidelines are followed, so that we can continue to enjoy the rural lifestyle that we all love so much and moved here for.
